**Due upon acceptance. Fee will hold student placement until Payment #1 is received.*

Payment #1 is invoiced in May and due June 1st or upon acceptance afterward. Once billed via FACTS, you are financially responsible for Payment #1 (non-refundable & non-transferable). To be released of financial obligation for Payment #1, a written "Notice of Withdrawal" form is required by May 1st. Families withdrawing after May 1st remain financially responsible for Payment #1.

Re-enrollment fees: Your account must be current in order to re-enroll for the upcoming school year. Families must submit re-enrollment documents via RenWeb and pay re-enrollment fees. If a re-enrolled family’s “Payment #1” for the next school year has not been received by June 10th, WHCS cannot guarantee enrollment. Once re-enrolled, you are financially responsible for next year’s tuition. **To be released of this obligation, a written “Notice of Withdrawal” form must be received by May 1st. If received after May 1st, Payment #1 will still be due.**

Late payment fee: \$30 after the 10th of the month.

NSF fee: \$30 assessed for ANY check paid to WHCS that is returned “Non-Sufficient Funds.”

Failure to pay past-due accounts: After 30 days, the account may go to a collections agency. Any fees, including attorney fees, will be the responsibility of the parents/guardians. School policy states that dismissal may result if payment

Transfers & withdrawals: When a student enrolls or withdraws from the school, the tuition and /or financial aid charge liability will be determined by applying the appropriate percentage of annual tuition:

Families must submit a Notice of Withdrawal form with the Admissions Office no later than 30 days before date of withdrawal, or be subject to an additional fee.
